8 to 11th March 2016**

Japan is one of the largest importers of agricultural and processed food products in the world. The major products imported by Japan are maize, processed fruits and vegetables, buffalo meat, alcoholic beverages, wheat, fresh fruits & vegetables, poultry products, cereal preparations, dairy products, floriculture etc.

The major items exported from India are processed fruits and vegetables, guar gum, dairy products, poultry products, cereal preparation, cucumber & gherkins, groundnuts, floriculture, maize, mango pulp, etc.

Ms. Sunita Rai, AGM and Mr. SS Rawat are nominated to organize APEDA's participation in this show. APEDA has booked fully constructed and furnished stand of 108sq.mts. The subsidize charges for a booth of per 9 sq. mts is Rs 50,000/- and the selection of participants would be through lottery system. Participants will have to make their own arrangements for visit, despatch and clearance of samples. APEDA will assist in getting visa invitation for the participants subject to timely submission of prescribed documents.
