3. Rates should be quoted for the entire materials. Part rate or conditional rates will not be considered for acceptance.
4. Caution money to be deposited along with the offer is 25% of the total offered value i.e Rs. 33,066.00 in the form of Bank draft drawn in favour of APEDA, New Delhi.
5. Without Caution money no auction bid will be considered and the bid will be rejected summarily.
6. Contract will be awarded to the highest bidder. However, APEDA reserves right to reject any or all bids without assigning any reason thereof.
