**Packing specifications :**

Wood-w001, saw-dust, paper and plastic must be used as packing material and it is prohibited to use hay, straw, chaff, moss, leaves and other vegetable materials as packing material which may be carrier of quarantined harmful organisms.

While importing each type of quarantined product in the Republic of Kazakhstan it must be packed in individual packing.

**Restrictions on import :**

**Availability of phytosanitary documents (in compliance with the list for quarantined products\*) :**

Phytosanitary certificate, issued by the competent authority of the country-exporter.

\*) The list of products under quarantine (regulated goods, regulated articles of regulated goods) to be quarantined phytosanitary control (supervision) at the customs border of the customs union and the customs area, customs union, approved the decision of the Customs Union Commission on June 18, 2010.
