APEDA is participating in world Food Moscow being held at Export Centre, Krasnaya Presnya, Moscow, Russia during 13-16 September 2011. Russia is the nerve center for the whole of CIS region and our exports to Russia during the last three years have been hovering around Rs.200 crores + with major items of export being processed, preserved fruits and vegetables, guar gum, jaggery and confectionery, mango pulp etc

APEDA has taken a pavilion space of 45 sq mtrs. We are getting the stall decoration done by a professional agency and a maximum of 10 exporters can be accommodated with some shelf space. Therefore we are inviting interest from exporters to participate in this exhibition through APEDA stand. The requests will be entertained **at first cum first serve basis**.

While under the Market Development Assistance (MDA) Scheme Russia qualifies as an eligible focus area but as per Government of India guidelines MDA would be applicable only if 10 exporters participate through APEDA pavilion. Therefore, interested participating exporters can also file their application for MDA but eligibility would be decided on the above grounds. - 3. E.mail us your pass port copy along with intended date of departure and return GIVING DETAILS LIKE passport NO., Name as appearing in passport, Place of issue, Date of Issue and Validity.
- 4. MDA will be applicable for one representative from one company subject to other quidelines as mentioned above.

Therefore, in view of the above and the limited space available an effort should be made that just one representative of a company participates.
