<u>Terms of Reference (TOR) for Supply, installation, commissioning and</u> <u>Comprehensive AMC of UPS system at APEDA, New Delhi</u>

The Agricultural and Processed Food Products Export Development Authority (APEDA) invites sealed tenders for following activities:

- 1) For supply, installation and commissioning of 15 KVA Online UPS with 3 years onsite warranty. The specs of the UPS are mentioned in Annexure –A. The online UPS is to be installed at APEDA 4th floor, NCUI building, 3 Siri Institutional area, August Kranti marg, New Delhi 110016. The vendor has to submit the quotations with buyback offer of offline UPS mentioned in Annexure-III.
- 2) For civil work at 4th floor for installation & commissioning of separate UPS electrical line along with installation of electrical points in each cabin for each& every desktop computer. For this purpose, vendors are advised to do a pre-inspection of APEDA premises.
- 3) For AMC of online & offline UPS installed in APEDA, New Delhi premises at 3rd & 4th Floor:

Technical Specifications, Terms and Conditions, the formats and pro-forma for submitting the bids are described in this document.

Secretary APEDA

Terms and Conditions for Online and Offline UPS

- 1. The terms of reference for Onsite Comprehensive Annual Maintenance Contract (including labour charges, original spare parts, transformers etc.) along with 3 Online UPS (30 KVA, 10 KVA & 10 KVA) and 2 offline UPS.
- 2. The vendor/agency should give an undertaking that it has not been black listed by any Government/Autonomous/PSU type organizations.
- 3. Joint bids and outsourcing or subletting of any nature / third party would not be acceptable.
- 4. Work Order for all UPS may be issued to one party/agency (lowest price quote L1 as a whole tender value).
- 5. The vendor/agency must have a good support technical team.
- 6. The UPS can be inspected by the interested tenderer on any working day between 10.00 hours to 1600 hours (except between 1300 to 1400 hours) by contacting the Executive Officer (IT), APEDA, New Delhi.
- 7. Accessories and spare parts of the Online UPS should be replaced with the original parts. The complaints must be registered directly to Vendor selected after bidding.
- 8. Downtime of the Uniline & other make online UPS should be only at the time of repairing or maintenance or firmware upgradation.
- 9. At the time of breakdown engineer should report APEDA, within maximum 4 hours.
- 10. The UPS should be attended by the firm's engineer within 12 hours from the time of lodging the complaint in case of a fault and if the UPS remains unattended for the complaints for 24 hrs after lodging the complaint and find the UPS remain non functional beyond 2 days, it will be counted as "Penalty days". The validity of contract period shall be extended by the total number of "Penalty days" during which time the contractor should continue to render the maintenance / operation service under the contract without any additional remuneration. In addition to each penalty day, the contractor shall be liable to pay a penalty fee Rs 1000/- per day and the same shall be deducted from the bill submitted by the contractor.
- 11. Consequential, damages, and losses arising out of any faulty maintenance / service / repair will be recovered from the contractor at the time of payment of bills.
- 12.In case of major fault in UPS contractor has to provide standby UPS of same specifications.

- 13. Vendor/agency should quote the rates for the onsite comprehensive maintenance (including labour charges and original spare parts) of the all types of UPS.
- 14. No Travelling or miscellaneous charges will be paid by the APEDA for any visit of engineer.
- 15. No courier or transportation charges for spare parts delivery/pick up will be paid.
- 16. The payment will be made only after successful completion of each quarter and on presentation of bills in duplicate copy by the vendor/agency.
- 17. No advance payment on any account will be made for AMC period.
- 18. The decision of the APEDA shall be final and binding upon in the event of any dispute arising out of the terms of the contract.
- 19.In the event of assigned services/work being carried out by the vendor not found satisfactory by the APEDA, the contract shall be liable to be terminated and the APEDA shall have discretion to get the remaining work carried out from any other vendor besides forfeiting performance security etc.
- 20. No alteration made to the tender conditions will be acceptable.
- 21.APEDA reserves the right of rejecting all or any of the tenders by not mentioning any reason thereof.
- 22. The charges for online and offline UPS maintenance and its operation should be quoted as per Annexure-III.

Period of Contract:

The period of contract shall initially be for one year from the date of commencement of the contract. It may be extended maximum upto three years on the basis of performance of the service provider. However, APEDA reserves right to review the performance of the service provider, and also to terminate the contract at any point of time during the currency of contract in case the performance and the service rendered by the contracted firm is found to be unsatisfactory.

Bid Submission:

The bid to be submitted by the Bidder shall consist of 2 (two) parts:-

Part - I :- "Technical Bid" (1st Envelope) shall contain:-

i) All the supporting documents as per the Eligibility criteria Annexure –II

Part - II :- "Financial Bid " (2nd Envelope) shall contain:-

i) Financial proposal as per the format Annexure-III

The bidder shall seal the two envelopes (both technical & financial bids in two separate envelopes) and put in one outer cover super scribed with "Tender for Supply, installation, commissioning and Comprehensive AMC of Online UPS system at APEDA, New Delhi" and submit it within the timeline the bid submission.

Vendor Selection:

Bids shall be opened by a committee constituted by competent authority of APEDA.

No bidder shall be called during opening of the bids.

APEDA reserves the right of rejecting all or any of the tenders by not mentioning any reason thereof.

Vendor shall be selected on the basis of L1 in activity a) & b) combined:

- a. For supply, installation and commissioning of 15 KVA Online UPS. Considering the buyback offer price, the final price for supply of 15 KVA supply, installation and commissioning would be calculated after deducting the buyback price.
- b. For civil work at 4th floor for installation & commissioning of separate UPS electrical line along with installation of electrical points in each cabin for each & every desktop computer. Rate should be minimum.

Vendor shall be selected on the basis of L1 for AMC separately:

c. For AMC of online & offline UPS installed in APEDA, New Delhi premises at 3rd & 4th Floor as per list mentioned at Page no 1.

- 1. UPS shall be free from workmanship defects, sharp edges, nicks, scratches, burst, etc. All fasteners shall be fixed properly. The equipment shall be complete with all parts and all parts shall be functional.
- 2. UPS shall have switches for: Mains ON/OFF MCB, Battery ON/OFF MCB/Fuse, Inverter push button with reset
- 3. UPS shall have static and manual by pass facility
- 4. The charges should be quoted including supply, installation and commissioning of UPS system at APEDA 4th Floor, NCUI Building, 3 Siri Institutional area, August Kranti marg, New Delhi 110016. Buyback offer rate of each offline 500/600 VA UPS should be mentioned in the financial quotes as per Annexure-III
- 5. Connectivity of input from Mains and output upto MCB has to be provided by the vendor. Onsite inspection may be done before submission of bids.
- 6. As per Meity (Government of India) guidelines storage battery shall have valid BIS CRS certifications as applicable as on date
- 7. As per Meity (Government of India) guidelines UPS shall have valid BIS CRS certifications as applicable as on date
