# REGISTRATION OF CONTRACTS FOR EXPORT OF PUSA - 1121 VARIETY OF NON - BASMATI RICE

Vide Notification No 38 (RE-2008)/2004-2009 dated September 5, 2008, issued by Director General of Foreign Trade, Govt. of India, New Delhi (DGFT) the export of PUSA – 1121 variety of Non-Basmati Rice is allowed subject to the following conditions:

- 1. Export allowed subject to registration of contracts with APEDA, New Delhi, prior to shipment;
- 2. Export permitted only if the minimum FOB price is US\$ 1200 per ton or Rs. 48,000/- per ton;
- 3. Export will be restricted through the following ports only:-
  - (i) Kandla
  - (ii) Kakinada
  - (iii)Kolkata
  - (iv) JNPT, Mumbai
  - (v) Mundra, and
  - (vi) Pipavav
- 4. Export shall be allowed with immediate effect, out of paddy procured in KMS 2008-09.
- 5. Subject to conditions imposed vide Notification No 32 dated 19<sup>th</sup> August 2008

APEDA has evolved the following procedure for the Registration of the Contracts and issuance of Registration-cum-Allocation Certificate (RCAC).

PROCEDURE

Application for Registration of Contracts for export of PUSA – 1121 variety of Non-Basmati Rice will have to be filed by the exporters on line at APEDA website viz.www.apeda.com

The applications will be received in the office of the Agricultural and Processed Food Products Export Development Authority (APEDA), 3<sup>rd</sup> Floor, NCUI Building, 3 Siri Institutional Area, August Kranti Marg (Opp.Asiad Village), New Delhi – 110016 or one of its regional offices. (Detailed addresses at Annexure I)

PROCESSING CHARGES

Processing charges of Rs. 10 per MT of the contracted quantity shall be paid by the applicants. This amount shall be paid by Demand Draft/pay Order drawn in favour of APEDA. All applications for registration of contracts should be accompanied by Demand Draft/Pay Order of requisite amount.

REGISTRATION

The applications shall be scrutinized in the office of APEDA and a Registration-Cum-Allocation Certificate (RCAC) shall be issued to the applicants for quantity contracted.

**VALIDITY** 

The RCAC shall be valid for such period as may be specified in the LC/Contract.

SELF CERTIFICATION It would be mandatory for the exporters to furnish, along with their application a self certified certificate certifying that the product sought to be registered and exported is i) PUSA-1121 variety of Non-Basmati Rice, and ii) of Indian origin.
