#### **SUB: LAUNCH OF AN INTERNATIONAL CALL FOR PRE SELECTION OF FOREIGN POWDERED MILK EXPORTERS**

This has reference to communication received from Embassy of India, Algiers intimating about the launch of an international call for the pre selection of frozen powdered milk exporters by EPE-FRIGOMEDIT/SPA, an Algerian public economic company, specializing in the cold storage and export of fresh agricultural products. It has further been informed that EPE FRIGOMEDIT/SPA will select milk powder exporters from those who respond to the international call for pre-selection.
