**APEDA's Participation in GULFOOD 2023, Dubai, UAE from 20 to 24 February, 2023**

Dear Exporter,

As you are aware that the **GULFOOD** is an International Food Fair is considered to be one of the largest and exclusive fair in the Middle East region. It is very popular among the importers and exporters of agro products around the world. This important trade event attracts a coterie of participants of diverse nationalities. Exhibitors and visitors from almost every country in the world meet here to conduct cross-border business and establish international contacts in the trade arena.

Considering the importance of the event APEDA is organizing its participation with the prominent exporters of India for promotion of Agricultural and Processed Food Products. Being the International Year of Millets focus would be given to Millet and its value added products. The Gulfood is scheduled to be held at World Trade Center, Dubai, UAE from 20 to 24 February, 2023. APEDA has booked 594 Sq. mtr. area for design and development of India pavilion for export promotion of various food products.

The India pavilion would have around 50 stalls of 9 Sq. mtr. each. APEDA invites application from the registered member exporters for participation in the Gulfood 2023 under the India pavilion.

Contribution of Participants of the stalls is as follows:-

1. One 9 Sq. mtr. build up and furnished stalls Rs. 6,50,000/-.
2. 10% extra for the corner stalls.
3. The discount of 20% would be given to Start-ups, SC/ST & Women enterprises.

The preference would be given to first time participants with APEDA that may be given to export of Millets and value added product in view of IYoM 2023.

The APEDA registered member exporters to send their application in the prescribed format along with payment for participation. The request for participation in the event would be considered up to 5:00 pm on 23/12/2022. In case the applicants are more than the availability of stalls. The allocation would be made through draw of lots, After scrutinizing the applications complete in all respects and as per products eligible for this event.
