विषय: आईटीसी (एचएस) 2022, अनुसूची-I (आयात नीति) को वित्त अधिनियम, 2023 (2023 की सं. 8) दिनांक 31.03.2023 और विदेश व्यापार नीति, 2023 के समकालिक बनाने के संबंध में।

सा.आ.(अ): विदेश व्यापार नीति, 2023 के पैरा 1.02 और 2.01 के साथ पठित विदेश व्यापार (विकास एवं विनियमन) अधिनियम, 1992 (समय-समय पर यथा संशोधित) की धारा 5 के साथ पठित धारा 3 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, केन्द्र सरकार एतद्वारा 'आईटीसी (एचएस), 2022, अनुसूची-I (आयात नीति)' को वित्त अधिनियम, 2023 (2023 की सं. 8) दिनांक 31.03.2023 के समकालिक बनाने हेतु निम्नानुसार संशोधित करती है-

2. वित्त अधिनियम, 2023 की समकालिकता में आईटीसी (एचएस) कोड 2022 में शामिल किए गए/हटाए गए/संशोधित किए गए/विभाजित किए गए/विलय किए गए आईटीसी (एचएस), कोडों और संबंधित नीतिगत शर्तों की सूची इसके साथ (अनुलग्नक I) संलग्न है।
3. वित्त अधिनियम, 2023 की समकालिकता में आईटीसी (एचएस) कोड की खंड टिप्पणियों, अध्याय वार मुख्य टिप्पणियों, पूरक टिप्पणियों, अध्याय शीर्षक, उपशीर्षक और विवरण में संशोधन इसके साथ (अनुलग्नक II) संलग्न है।
4. विदेश व्यापार नीति, 2023 की समकालिकता में संशोधित आईटीसी (एचएस) 2022, अनुसूची-I (आयात नीति) के तहत आईटीसी (एचएस) विशिष्ट नीतिगत शर्तों और अध्याय विशिष्ट नीतिगत शर्तों की सूची इसके साथ (अनुलग्नक III) संलग्न है।
5. आईटीसी (एचएस) 2022, अनुसूची-I (आयात नीति) में 'एफटीपी (2015-20)' के किसी भी उल्लेख को 'एफटीपी 2023' के रूप में संशोधित कर पढ़ा जाए।
6. अद्यतित आईटीसी (एचएस) 2022, डीजीएफटी की वेबसाइट (<https://dgft.gov.in>) पर उपलब्ध होगा।

**इस अधिसूचना का प्रभाव:** आईटीसी (एचएस) 2022, (अनुसूची-I) आयात नीति को वित्त अधिनियम 2023 और विदेश व्यापार नीति 2023 के समकालिक संशोधित किया गया है। यह तत्काल प्रभाव से लागू होगी।
