

Circular

This has reference to the trade notice issued by APEDA on 20.04.2017 for allocation of quota of 5000MT for export of organic pulses. As per the said trade notice, the quota of 5000 MTs of organic pulses was to be allocated to the exporter on the basis of the highest FOB price for export in USD per MT calculated on the basis of weighted average realization per application. The applications received from 24 exporters in sealed envelopes were opened on 05.05.2017 in the presence of the representatives of the exporters.

A total of 157 applications were received for a total quantity of 3298.836 MT. Therefore, all 157 applications have been considered for allocation of quota subject to submission of the Performance Bank Guarantee, Provisional Transaction Certificate (PTC) and other requisite documents as specified in the APEDA Trade Notice dated: 20.04.2017 to enable APEDA to issue RCAC.

In case the Performance Bank Guarantee is not submitted within 7 days or other relevant documents submitted are not in order, the quota allocated will be withdrawn.
