Advisory for Compliance of Export of Peanut and Peanut Products to Indonesia

The Indonesian Quarantine Authority (IQA) has agreed to reinstate the export of Indian peanuts to Indonesia after carrying out the onsite visit to peanut farm, processing unit, recognized food testing laboratories and ports and review of revised Export Procedure for Peanut and peanut products. The reinstatement has been agreed upon based on compliance to certain specific requirements for each Peanut consignment (enclosed as Annex-I). Though these requirements are largely part of the Export Procedure of APEDA, the exporters may ensure adherence as the frequency of the risk-based inspection at port of arrival for initial period of reinstatement depends on the compliance.

It has also been agreed upon that in the event of non-compliance in any consignment, the exporter shall be suspended immediately and shall not be eligible for export to Indonesia.

The exporters are advised to comply with the Export Procedure of APEDA as a whole and the specific requirements for export to Indonesia.

Specific requirements for export of Peanut and Peanut products to Indonesia

1. Peanut sourcing:

- a. Peanuts intended for export to Indonesia shall be sourced from farms following Good Agricultural Practices (GAP) and Good Handling Practices (GHP).
- b. Peanuts shall be properly dried to achieve a moisture content not exceeding 7%, to prevent aflatoxin contamination.
- c. The drying process should follow Codex guidelines (CAC/RCP 55-2004). Pods must be kept uppermost, away from soil, and exposed to sun and wind. Drying should be completed promptly to achieve safe moisture levels.
- d. Shelling shall be carried out under dry and hygienic conditions by a processing unit registered by APEDA. Use of water during shelling is not permitted to prevent increased moisture and aflatoxin risk.
- e. Following Codex guidelines (CAC/RCP 55-2004), farmers' stock peanuts shall be screened for aflatoxin contamination. Aflatoxin-free loads shall be stored separately, low-contamination loads shall be directed to processing or cleaning, and highly contaminated loads shall be handled separately to prevent cross-contamination.
- f. Peanuts shall be stored under dry and hygienic conditions in facilities that prevent moisture uptake, pest infestation, and cross-contamination. Different lots shall be segregated according to aflatoxin contamination levels to ensure food safety and quality.

2. Exporter and Processing Unit Eligibility:

- a. Only exporters and processing units registered under APEDA and further approved by the IQA are permitted to export peanuts to Indonesia. The list of eligible exporters received from IQA is annexed.
- b. The list of eligible exporters and processing units will be published on the official website of the IQA and secured through the Prior Notice system.

3. Packaging and Container Requirements

- a. Peanuts must be exported in new, clean, and food-grade packaging materials to ensure product integrity and safety.
- b. Containers must be suitable for food transport, clean, free from rust, leakage, and contamination, and exporter must have submitted a self-declaration to APEDA before shipment.
- c. Each consignment must carry clear traceability information, indicating the exporter, processing unit, lot number, and other relevant identification details in accordance with APEDA's export procedures and IQA's import requirements, to ensure identification throughout the supply chain.

d. To prevent sweating and condensation inside the container during shipment, the exporter shall:

- i. Place suitable moisture absorbers inside the container for each consignment.
- ii. Instruct the shipping line to keep container flaps open, store the container in a well-ventilated area on the vessel, and
- iii. Line all sides and the top of the container with kraft paper before loading.

4. Sampling, Testing, and Export Certification

- a. Sampling and testing shall be conducted by an IQA-registered laboratory for each consignment, based on Codex Guidelines.
- b. The sampler shall record the geo-coordinates of the sampling location and seal the sampled lots before dispatch.
- c. The laboratory shall issue the Certificate of Analysis (CoA) within four (4) days (96 hours) after sampling.
- d. The Certificate of Analysis (CoA) must be issued in a manner that allows its validity to be verified using appropriate tools or systems.
- e. The consignment shall be shipped at the earliest after the issuance of the CoA and not later than **35 (thirty-five) days from the date of CoA issuance**, to ensure that the test results remain valid.
- f. Shifting/relocation of the consignment wherein sampling was carried out shall be done only in the presence of the laboratory personnel and re-sealing should be done.
- g. The exporters must ensure that containers are suitable for food transport, clean, free from rust, leaks, and contamination. A report with photographs including geo-coordinates, must be sent to APEDA for approval before issuance of the Certificate of Export (CoE).
- h. Loading (stuffing) of the peanuts into containers shall be conducted by the exporters and the self-declaration shall be submitted to APEDA.
- i. The exporters shall confirm that the container is fit for food transport, clean, and free from rust, leaks, and contamination.
- j. APEDA shall issue a Certificate of Export (CoE) upon confirmation that the Certificate of Analysis (CoA) and the self-declaration have fulfilled Indonesia's requirements.
- k. The Phytosanitary Certificate will be issued by the National Plant Protection Organization (NPPO) of India based on export inspection by quarantine officer of India to meet phytosanitary requirements of Indonesia.
- l. The Certificate of Export (CoE) issued by APEDA shall be submitted by the Indian peanut exporter to IQA and the copy of the document shall accompany each consignment.
