Advisory on export of Fresh Fruits and Vegetables to France

In reference to the notified order adopted by the French authorities pursuant to Article 54 of Regulation (EC) No 178/2002, France suspends the importation, introduction and placing on the market of foodstuffs or animal feed containing residues (even below MRL) of the following certain active substances which includes Glufosinate, Mancozeb, Thiophanate-Methyl, Carbendazim and Benomyl.

Kindly note that this suspension concerns various fruits, vegetables, cereals, mushrooms and algae, in which residues of the substances concerned may also be present at levels that are a cause for concern.

The details of the foodstuff/substance and the corresponding agrochemicals under prohibition are given below:

Food Stuff (Raw or Processed)	Plant Protection substance
Grapefruit, Oranges, Lemons, Limes, Clementines/Tangerines, Apples, Pears, Quince, Loquats, Loquat Other, Pome Fruits, Apricots, Cherries (Sweet), Peaches, Plums, Table Grapes, Wine Grapes, Mangoes, Papayas, Tomatoes, Eggplant, Okra, Brussels Sprouts, Beans (with pods), Peas (with pods),	Carbendazim and Benomyl

Cultivated Mushrooms, Soybeans, Barley, Oats, Rye, Wheat Potatoes	
Grapefruit, Oranges, Lemons, Limes, Clementines/Tangerines, Apples, Pears, Quince, Loquats, Loquat, Other Pome Fruits, Apricots, Cherries (Sweet), Peaches, Plums, Wine Grapes, Mangoes, Papayas, Tomatoes, Eggplant, Okra, Melons, Pumpkins, Watermelons, Brussels Sprouts, Seaweed and Prokaryotic Organisms, Soybeans, Barley, Oats, Rye, Wheat	Glufosinate Thiophanate-methyl
Avocados, Table grapes, Mangoes, Papayas, Blackcurrants, Strawberries, Potatoes, Peppers, Melons, Lettuce	Mancozeb

Therefore, it is advised that the exporters may implement risk mitigation measures or refrain from exporting consignments containing residues of these chemicals to France.
