Subject: Amendment for extension of validity of Minimum Export Price (MEP) on export of Natural Honey – regarding.

S.O. (E): In exercise of powers conferred by Section 3 read with Section 5 of the Foreign Trade (Development & Regulation) Act, 1992 read with Para 1.02 and 2.01 of the Foreign Trade Policy, 2023, as amended from time to time, and in amendment of the earlier Notification No. 27/2025-26 dated 22.08.2025, the Central Government hereby extends the validity of the existing Minimum Export Price condition of Natural Honey under ITC(HS) code 04090000 of Schedule-II (Export Policy), as under, with immediate effect:—

Tariff item HS Code	Item description	Export Policy	Existing Policy condition	Revised Policy condition
04090000	Natural Honey	Free	Subject to a Minimum Export Price (MEP) of US Dollar 1400 FOB per Metric Ton, till December 2025.	Subject to a Minimum Export Price (MEP) of US Dollar 1400 FOB per Metric Ton, till 31 st March 2026.

2. Effect of this Notification:

Minimum Export Price (MEP) on Natural Honey (exported under ITC HS Code 04090000) shall remain at US Dollar 1400 FOB per Metric Ton till 31st March 2026, with immediate effect.
