TRADE NOTICE

REGISTRATION OF CONTRACTS FOR EXPORT OF PULSES

Vide Notification No. 28/2015-2020 dated September 15, 2017 issued by Director General of Foreign Trade, Govt. of India, New Delhi (DGFT) the export of Pulses (Toor Dal, Moong and Urad) have been made free for export till further orders.

1. The export of these Pulses (Toor Dal, Moong and Urad) will only be allowed after registration of contracts with APEDA.
2. Export shall be through custom EDI ports.
3. Export through the non-EDI Land Custom Stations (LCS) on Indo- Bangladesh and Indo-Nepal border shall also be allowed subject to registration of quantity with DGFT. Regional Authorities (RAs) in Kolkata and Patna and such other RAs as notified by DGFT from time to time.

APEDA has, therefore, evolved the following procedure for the Registration of the Contracts and issuance of Registration-Cum-Allocation Certificate (RCAC).

PROCEDURE

Application for Registration of Contracts for export of Toor Dal, Moong and Urad will have to be filled by the exporters on line at APEDA website viz. www.apeda.gov.in

**PROCESSING
CHARGES**

Processing charges of Rs.10 per MT plus GST at the rate of 18% of the contracted quantity shall be paid by the applicants. This amount shall be paid online.

REGISTRATION

APEDA shall issue Registration-Cum-Allocation-Certificate (RCAC) to the applicants online for quantity contracted.

VALIDITY

The RCAC shall be issued with validity for shipment upto 45 days from the date of issue. Therefore, while applying for Registration of Contract exporters are advised to ensure that the quantity applied for registration is the one which is planned to be shipped in next 45 days.

RCAC once issued will not be amended in respect of the particulars of the buyer and FOB price.
